#### I Accounting Policies and Proceedures :

- 1.The Financial Statements are prepared on historical cost convention and in accordance with generally accepted practices following Cash method of accounting for recognising Income / expenditure, except noted otherwise.
- 2 Amount spent /received as adjusted by sponsoring body M/S SIDDHARTHA ACADEMY OF GENERAL AND TECHNICAL EDUCATION (SAGTE) on behalf of the Institution are accounted on accrual basis as per advises received from them.
- 3. During the Year The Institution applied and received Deemed to be University approval on 11.03.2024 under the name SIDDHRTHA ACADEMY OF HIGHER EDUCATION. In the process the Institution paid Rs 22,00,000 towards processing fee which is shown under the head Affiliations and renewals. The Institution also collected Registration fee from prospective students fo academic year 2024-25 of Rs 2,41,200 which is shown under the head Other receipts
- 4. The Institution received Rs 28,00,000 from KCP Limited during FY 2022-23 for setting up 3D Concrete Printer in COE (CIVIL Engineering department ). The Institution spent an amount of Rs 28,75,032 during FY 2023-24 for setting up the Lab facility. Accordingly Rs 28,00,000 was shown under Capital Grants and utilisation of Rs 28,75,032 is shown under Equipment acquired under Capital Grants.
- 5. Expenditure incurred on additions to equipment /Assets ,not of enduring in nature, in Management opinion are charged to Income and expenditure account under the head Repairs, Replacement ,Maintenance and Upkeep
- 6 Advances due from/ to persons/ parties are stated as per books of account and are subject to confirmation and reconciliation.
- 7. Depreciation charged under Written down value method @ 10% on Civil structures( finished and in use) and 15% on Equipment grouped under Fixed assets .
- 8. Advances recoverable include certain amounts pending over long time and are said to be under legal process totalling of Rs 3,62,647.13 and recoverability or otherwise of the same as on Balance sheet date is not ascertainable.
- 9. Reconciliation by student wise for Caution deposit payable is pending.
- 10 Previous year figures are rounded off to the nearest rupee and regrouped wherever necessary to make them comparable with those of the current year
