I, Mr./Ms \_\_\_\_\_ (Name) Son/Daughter of Sri \_\_\_\_\_ (Father Name). I hereby affirm that, I shall scrupulously adhere to the rules of conduct being in force at the University. I would not take up or participate in any activity that would be detrimental to the prestige of the University.

Further, I agree to abide by the rules and regulations as specified below:

**RULES & REGULATIONS**

1. I shall abide by university to take any appropriate action as deemed fit in exigencies to protect or maintain general discipline, prestige and standards of the University and such other decisions as are final and binding on the students.
2. Students of the University are not permitted to resort to strikes and demonstrations within the university. Participation in any such activity shall automatically result in dismissal from the university.
3. No student Unions except professional associations are permitted in the university.
4. Any student responsible for bringing outsiders into the University campus for setting student disputes will be expelled from the university.
5. Smoking, consumption of alcoholic drinks, playing cards, gambling of any kind is prohibited within the university premises.
6. Students should not sit on the parapet walls or on the steps or on the staircases. They are forbidden from loitering in the verandas or on the campus at anytime during the session of the university.
7. Students are forbidden from smoking inside the university premises.
8. Students should keep their vehicles only at the place allotted for the purpose. Vehicle Races on the campus is strictly prohibited.
9. Any student found to be violating the rules of conduct and discipline will be dealt with severely including expulsion from university. Their misbehaviour will also be reflected in the conduct certificate issued at the time of leaving the university.
10. No one should indulge in ragging or Eve-Teasing in any form which attracts serious punishment and entails summary dismissal also, vide Andhra Pradesh Prohibition of Ragging Act, 1997.

11. All candidates who secure admission in the University are deemed to have agreed to all **(Page....2...)** regulations as and when added, deleted or amended from time to time. If any clarification or doubt arises in respect of the above rules and regulations, I shall abide by for the University to issue the clarification and it is final and binding on me.
12. All candidates, provisionally selected for admission will be required to pay the prescribed tuition fee and other specified fee. Failure of the same will result in the cancellation of provisional admission.
13. All the students who secure admission in this University should display Identity Cards on person compulsorily on the campus. (Not in pockets).
14. Following Informal Dresses are not allowed:
  - (a) T-Shirt
  - (b) Over sized, under sized, unshapely shirts
  - (c) Dhotis, Kurta, Pyzamas, Shorts and Jeans.
  - (d) Slippers, Track Pants, Flowery Shirts with Casual Images.
  - (e) Dropping Pants, Sleeveless blouse, Baggies, Cargos etc.
15. Ragging within or outside the university campus is prohibited under prohibition of ragging in Educational Institution Act of 26 of 1977. A student against whom there is prima facie evidence of ragging in any form will be viewed seriously according to Ragging Act.
16. The students should follow any other rules framed by the University from time to time.
17. Misconduct committed by a student outside the University campus but having the effect of damaging, undermining & tarnishing the image & reputation of the University will make the student concerned liable for disciplinary action commensurate with the nature & gravity of such misconduct.

**GUIDELINES FRAMED AGAINST RAGGING**

1. Except parents and guardians, no person shall enter the University or Hostels without permission of the authorities.
2. Students indulging in ragging shall be suspended and debarred from entering the campus except for attending enquiry or/and submitting explanation.
3. All students shall possess identity cards and show them on demand.
4. The authorities or teachers entrusted with this work, can inspect the hostels at any time.
5. Ragging is prohibited as per Act of A.P. Legislative Assembly, 1997.
6. Ragging entails heavy fines and / or imprisonment.
7. Ragging invokes suspension and dismissal from the college.
8. The CERTIFICATES of students involved in the ragging will be EMBOSSED “INVOLVED IN RAGGING”.

**Prohibition of Ragging in Educational Institution Act -26 of 1997**

**SALIENT FEATURES**

- # Ragging within or outside any Educational Institutions is prohibited.
- # Ragging means doing an act which causes or is likely to cause insult or annoyance or fear or Apprehension or threat or intimidation or outrage of modesty or injury to a student.

**Nature of Ragging**

1. Teasing, Embarrassing and humiliation.
2. Assaulting or using criminal force or criminal intimidation.
3. Wrongfully restraining or confining or causing hurt
4. Causing grievous hurt, kidnapping or rape or committing unnatural offence.
5. Causing death or abetting suicide

**Punishment**

- Imprisonment up to 6 months or fine up to Rs.1000/- or both.
- Imprisonment up to 1 year or fine up to Rs. 2000/- or both.
- Imprisonment up to 2 years or fine up to Rs. 5000/- or both.
- Imprisonment up to 5 years and fine up to Rs. 10,000/-
- Imprisonment up to 10 years and fine up to Rs. 50,000/-

**Note:**

1. A student convicted of any of the above offences will be expelled from the University.
2. A student imprisoned for more than six months for any of the above offences will not be admitted in any other University.
3. A student against whom there is prima facie evidence of ragging in any form will be suspended from the University immediately.
